Checking Accounts Reminders

NEWFCU Checking Accounts offer you the ability to make payments directly from your account! If you prefer to set up automatic payments, remember to use your checking account number rather than your debit card, or even use our Online Bill Payment service! With Online Bill Pay, you can choose to set up automatic payments or just make it easier to log in and pay your bills on your own schedule.

Your Savings (Share) Account cannot be used for payments, although you may elect to have direct deposits into this account.

Christmas Club Accounts

Did you know you can start your Christmas Club account at any time, with any amount?

You decide how much you want to contribute and when you want to contribute! Automatic transfers are encouraged for easy saving, but are not required for this account. There are no minimum balance or early withdrawal fees. Stop in or call for complete details.

Did you use your high interest credit cards to purchase that big-ticket gift? Are you looking for a way to relieve some of that stress? NE Welch FCU may be able to help you get the cash you need with our Holiday Loan promotion! Apply for a Holiday Loan through January 31, 2023 – rates start at just 4.99% APR for a one-year term!

Another easy option for our members is a Better Choice Loan. This loan offers a 3-or 6-month repayment term, up to \$1,000 maximum (dependent on income)



Passwords and Member to Member Phone Transfers



When you request information on your account(s) over the phone, we require you to tell us the Password you chose. This is to help protect your identity from fraudsters or other impersonators who may know the last four of your SSN or other information. If you are unsure if you have a password or if you've forgotten what you chose, please stop into either office to get one set up.

To make transfers over the phone to another member, we require that you have a Member-to-Member Phone Transfer form completed and signed by you. This form authorizes us to complete the transactions at your request, without needing a signature as we would if you were in-person.

These forms may be completed using our secure e-sign program, but we must have an email already on file. Please contact us with any questions.



IRA Fair Market Value

If you have an Individual Retirement Account (IRA) with the Credit Union, the ending balance listed on your December 31, 2022 statement is the fair market value of this IRA. This fair market value information is being furnished to the Internal Revenue Service.
